- As part of an acquisition team, worked with Business Operational Areas, Auditing, IT, and Executive Management. Performed: process and control reviews; data migration of the acquired entity's legacy and outsourced systems; and the documentation of several of the acquired company's business processes and controls.
- For a medium-size investment firm. reviewed and analyzed SOX process documentation and control testing processes and tools. Made and presented recommendations to streamline their "change revision" processes and identified ways to streamline the on-going required staff education. Performed several followup projects: developed new documentation naming and formatting standards: streamlined the change, testing and release of SOX related processes and controls; developed a stop-gap program which enabled them to manage the change process; and developed an RFP to find a cost-effective software solution to manage the required SOX information while providing a complete change audit trail.
- Working with the marketing area of a Private Bank. developed maior "community model" that is used to monitor specific targeted comprised of current and potential customers. Extensive use of internal and external data sources are gathered and analyzed on both a scheduled and ad-hoc basis to determine changes in the demographic relationship of purchasing channels, patterns, and volumes. Developed an executive dashboard for senior and middle management.

- software company engaged Advantageware to assist in documenting the required financial controls for SAS 70 Certification. Α small team of documentation specialists worked with IT and Business Operations staff. This team first developed the necessary standards and procedures required to produce and maintain the certification and future SAS 70 audit controls and documentation. Next, developed a tool set to enable the client to implement full "changemanagement" procedures. Advantageware staff members then documented financial controls on an as-assigned basis.

enhancements to existing software and performed extensive system and regression testing. In addition, Advantageware worked with the business unit staff to develop a user acceptance testing strategy and related test cases that would enable the software and all of its subsequent releases to be reliably tested quickly and accurately.

 A major bank engaged Advantageware to perform a Project Audit of its worldwide "Know Thy Customer Project" to determine if it was on target. This multistaged project required: an upgrade to the infrastructure hardware, corporate network, and operating system; the purchase, customization, and integration of a third party software solution; a massive data conversion and data loads to populate the new solution's databases; the development and worldwide deployment of specialized training programs; and a comprehensive testing strategy and program that included multiple iterations of both automated and "live" testing. A small team consisting of a senior management specialist, two senior business analysts and two technical specialists worked with the project team (bank business area experts and liaison personnel, bank operations and IT staff, third party vendors, and the bank's audit department). The resulting report provided management with the exact project status in terms of function, open issues, dollars spent and time and dollars remaining along with recommendations to resolve issues and how to improve inter- and intracommunication. Advantageware has been retained to continue working with the Project Management Office on an asscheduled basis.

In addition, much of our recent work is performed under the auspices of non-disclosure agreements. Without going into detail, a major portion of this work has dealt with uncovering and documenting white-collar crime. Our expert knowledge areas are: anti-money laundering; tracking the use and changing of employee personal and/or corporate and/or customer confidential data; performing "discovery" and documenting the misuse of actual data and transaction information; reconstruction of an event; identity theft and misuse; misuse of corporate identity and resources; standards and evaluation criteria development; and project management.

All of these engagements required "getting the job done" as quickly as possible while ensuring complete confidentiality, creating the correct audit trail, safeguarding client's assets and reputation, preventing recurrences, and arriving at a resolution with as little disruption as possible to the regular flow of business.
